Legislative Update - May 2024

General Comments.

Federal. While the details of the NDAA 2024 are still being worked out, the budget for NDAA 2025 is on the horizon with some possible ugly consequences for military retirees' health benefits. Personnel matters have always been a "soft target" for the budget balancers in the Congressional Budget Office (CBO and National MOAA believes that Tricare-for-Life (TFL) may be a target again claiming that it's too expensive. DoD has pushed for changes, but fortunately Congress has maintained the **status quo**.

In the meantime, I suggest to continue to beat the drums with our representatives/senators on the following issues:

Save Tricare-for-Life. It would be a pity to lose this essential benefit for all military retirees won in the NDAA 2001 after an almost twenty year battle. In the 2001 NDAA, Congress saw fit to include the following text in that bill in verbis: "While extending TRICARE/CHAMPUS eligibility to Medicare eligible beneficiaries, the conferees direct the Secretary of Defense to refrain from using deductibles and copayments, in recognition of their participation in Medicare Part B as a condition of participation" Request all look at MOAA's Advocacy in Action to ask your representative to not destroy this essential benefit for military members.

The Expanding America's National Cemetery Act (H.R. 1413), This is a significant piece of legislation protecting full uniformed services burial benefits introduced March 7 by Reps. Lisa McClain (R-Mich.) and Chrissy Houlahan (D-Pa.) is designed to preserve the option for full military honors now available at ANC and offers a long-term solution to Arlington National Cemetery (ANC) which would inevitably run out of room. It would authorize designating the next national cemetery location with equivalent honors to continue these benefits, rather than reducing eligibility at ANC. Please use the MOAA Advocacy in Action to follow up with our Representatives.

Respect for Military Families Act (H.R. 3232/ S.1588) This act would prevent the government from immediately recouping any overpayment of benefits and instead gives survivors the opportunity to repay the benefits over a 12-month period. It would also allow the secretary of defense to forgive the repayment. We need co-sponsors from our representatives and senators.

Military Spouse Hiring Act (H.R. 1277). This act will help spouses who are currently discriminated against for employment due to their husbands frequent transfers. Both Senators are on board as co-sponsors, however, we need to get our Representatives on board.


The Major Richard Star Act - Concurrent Receipt for Combat Injured Veterans: Two-thirds of Congress has supported this bill for the past two years. This legislation would reverse an unjust offset requiring these combat-injured retirees to give up a dollar of DoD-earned retirement pay for every dollar of VA-provided disability benefits they receive. We need to get our legislators back on board for the upcoming year.

<u>State.</u> With the current California budget crisis growing larger every day. It seems like the issues of interest to us are pretty much off the table. However, **stay tuned!** For those

who followed the recent elections regarding Governor Gavin Newsom's Proposition 1 Homeless Housing/Mental Health Bill which narrowly passed but will extend the state debt for 30 years.

Jeane Slone



The guest speaker at the April luncheon was Jeane Slone, author of several historical novels about women in the military. Using an in-depth PowerPoint presentation, she focused on her most recent book, SHE WAS AN AMERICAN COMBAT NURSE DURING WORLD WAR II. The book focuses on two nurses, one black and one white. Opposing narratives involving the two women, along with many photographs, convey the experiences and impact of segregation both in general society and in the armed forces in the 1940s. Among her many involvements, Slone is a member of the Redwood Writer's Club, Pacific Coast Air Museum, the National Women's History Alliance, and the Historical Novel Society. Five of her books were available for purchase.

Warren L. "Chris" Christianson November 29, 1929—April 16, 2024



On April 16, 2024, fittingly close to high noon, Warren L. "Chris" Christianson passed away suddenly in a fashion much like he lived - unequivocally. His failure to make it home for lunch with his beloved wife Marlys at the promised hour of 1 p.m. was, she noted, the first time he'd ever "stood her up" in their 70-plus years of marriage. Chris was born into a loving and gregarious family in November 1929 in Britton, SD. He was the youngest of the six children of Mary Elizabeth ("Mayme") Masse Christianson and Emil S. Christianson. He grew up in Cogswell, ND, where he excelled in sports at Cogswell High School. He attended the University of North Dakota before transferring to Valley City State Teachers College. While attending Valley City, he met and began dating Marlys Knutson.

Their 73-year love affair started when he offered a ride to Marlys and three other co-eds, as they walked back to their dorm. Chris and Marlys married in August 1953 while Chris was a cadet at the Pensacola Naval Air Station. They eloped and were married in the Catholic Church in Biloxi, MS.

Chris enlisted in the United States Navy in June 1952 and was awarded his wings in February 1954. Flying was his second love and he felt almost as passionate about it as he did about Marlys.

He served as a naval aviator in the United States Navy and Naval Reserves for 20 years, retiring as a Lt. Commander. He was a Commercial Pilot for Braniff International for 35 years, achieving the rank of Captain on the Boeing 747. He flew during the golden era of aviation, and always said "It beat working for a living."

He was a great husband, wonderful father and grandfather, loving son, brother, uncle, cousin, and friend. He loved his family dearly and took enormous pride in his three children, Catherine Fugit (Mark), Shawn Christianson (Philip McLeod) and

Clay Christianson (Nanette) and six grandchildren, Hailey Fugit, Brent Fugit (Mirtha), Spencer McLeod (Madison), Connor McLeod (Isabella), Chas Christianson and Gus Christianson. For him, family came first.

He was a faithful Roman Catholic, an avid Dallas Cowboys fan, and a fierce patriot. He was also a proud member of the Sons of Norway, Elks, Airline Pilots Association, American Legion, Knights of Columbus and Military Officers Association of America (MOAA"), for which he served as the President of the Redwood Empire Chapter. He also served on the City of Santa Rosa's Parks and Recreation Commission.
